4a (Code: ) (Expenses \$ 475,566 including grants of \$ 0 ) (Revenue \$ 475,566 ) Teacher Education - Provide quality professional development (workshops and institutes) and classroom materials to K-12 teachers to enable them to more effectively teach their students the economics and personal finance knowledge and skills needed to be successful in our dynamic economy. As a result of the financial support we receive from our partners, this professional development is provided at no cost to the teachers or their schools. In FY18, VCEE provided 101 sessions ranging from one hour to 42 hours in length to 1,415 Virginia teachers and 259 teachers from outside Virginia.

4b (Code: ) (Expenses \$ 55,565 including grants of \$ 0 ) (Revenue \$ 78,880 ) Stock Market Game - A program for grades 4-12 which provides teachers with a "real world simulation" to use with their students to teach math, social studies, business, economics and language arts while also learning about the stock market and how to invest wisely. Student teams "invest" \$100,000 and track how their investments perform over the life of the program. In FY18, more than 16,900 students across Virginia participated in the Stock Market Game. Eighteen workshops and webinars were held for teachers to assist them in integrating this program into their curriculum. VCEE also manages the statewide participation in InvestWrite, a writing competition around saving, investing and the stock market.

4c (Code: ) (Expenses \$ 37,170 including grants of \$ 0 ) (Revenue \$ 22,500 ) The Governor's Challenge in Economics and Personal Finance - This is a statewide competition for high school students held in conjunction with the Governor's Office. An online competition is initially held in three divisions - Personal Finance, Economics and Advanced Economics. Based on the results from the online portion, a live competition is held where regional champions compete against one another for the state championship. State champions are eligible to advance to national championship competitions. In FY18, over 3,200 students participated in the Governor's Challenge statewide.
